

- (j) To Take over institutions of similar objectives and develop to fulfill the Trust objectives.
- (k) To Develop Skilled human resources for the benefit of the Trust appointing deputed staff for specialized courses to the institutions in India or abroad at the cost and expenses of the Trust.
- (l) The Trustees shall have power to collaborate with national or international agencies for their educational expertise and techniques for the benefit of the Trust institutions and also to enter in exchange programs for teachers and students for mutual benefits.
3. The SETTLERS hereby deliver to the Trustees the following funds, namely Rs. 121/- be each of them in all totaling to **Rs. 605/-** to hold the same into and to the Trustees upon Trust and with, under the subject to the powers and provisions hereinafter contained.
4. The Trustees shall manage the educational institutions in such a manner as may be most beneficial to the growth and development of the institution and shall be responsible for the proper management and investment of the income of the institution and shall do everything as may be legally necessary for the maintenance and proper functioning of the institutions.
5. **Sri. V. KRISHNAMURTHY** shall be the PRESIDENT of all the Managing Committees, and Bank Transaction, which may be constituted by the Board of Trustees as and when necessary to run and supervise the different activities of the Trust.



6. The SETTLER (1), (2), (3), (4) and (5) shall also be the Trustees during their life and after death the eldest legal heirs and successor shall be a co-trustee is they have not nominated any other person to take their place as a Trustee by a validly executed document.
7. It is hereby declared that the PRESIDENT and Secretary Trustees shall have absolute power to dismiss any of the Trustees including the Founder Trustees in the event of such Trustees were to work adverse to the interest of the objects of the Trust. Similarly the President shall have absolute powers to appoint or dismiss any of the employees, with the consent of the Trustees.

The Trustee shall have the power to raise loans or advance repayable with or without interest from Banks or other or to alienate the Trust Property for purpose and in the course of the carrying on of the objects of the Trust. The Trustees shall also have the powers to raise funds by organizing benefit shows, of any type, exhibitions, fetes, lucky dips etc. to aid the implementation of the objects of the Trust.
12. The Trustees shall have the powers from time to time and at any time, to sell in and /or convert or other wise, dispose of the Trust properties and realize all or any of the securities, investments and assets and re-invest or utilize the same in such manner as may be deemed fit by them in accordance with the tenets of the Trust.
13. The PRESIDENT shall have full powers over the management of the Trust and Properties and funds they shall have full control over the finance of the Trust. They shall likewise be entitled to take all steps that may be constituted. Trusts or Educational Societies having similar aims and objects.
14. The Trust also can apply for 80G and it can open Fixed Deposit account in any Bank. And apply receipt under 80G Income-tax obtain the Trust name.
15. The Trustees shall have the power to appoint manger /managers for the Trust
16. The Trustees shall have power to frame rules for the conduct of their business.


22. The Board of Trustees shall have power to sanction all necessary payments from out of the funds of the Trust.

- (d) To do all such other lawful things as are incidental in carrying out the administration and management of the Trust.
33. 39. **INDEMNITY**

The Trustees shall be fully kept indemnified and harmless by the Trust against any action or claim, loss suffered or liability arising against them, on account of anything done by them in good faith pursuant to the powers and authority conferred on them by these presents.

40. **RIGHTS OF THIRD PARTIES OR BENEFICIARIES ;**



4. It is hereby declared that the **PRESIDENT** shall have absolute power to dismiss any of the trustees including the Founder trustees in the event of such Trustees in the objects of the Trust. Similarly the President shall have absolute powers to appoint or dismiss any of the employees with the consent of the Trustees.
5. The President shall also have power to appoint employees to the Trust and similarly shall have absolute discretionary powers to dismiss the services of any of the employees.


