- 8. The President shall have the power to raise loans or advance repayable with or without interest from banks or other or to alienate the Trust Property for purpose ad in the course of the powers to raise funds by organizing benefit shows, of any type, exhibitions, fetes, lucky dips etc., to aid the implementation of the objects of the Trust.
- 9. The President shall have the Powers from time to time and at any time, to self in and/or convert or otherwise, to buy land, lease, rent or dispose of the Trust properties and realize all or any of the securities, investments and assets and re-invest or utilize the same in such manner as may be deemed fit by them in accordance with the tenets of the Trust.
- 10. The PRESIDENT shall have full powers over the Management of the Trust and its properties and Funds, he shall have full control over the any finance of the Trust. He shall likewise be entitled to take all steps that may be constituted. Trusts or Educational Societies having similar aims and objects.

11. The Trust also can apply for 80G and it can open Fixed Deposit account in any Bank. And apply receipt under 80G Income Tax obtain the Trust name.

In case of any vacancy in the Board of Trustees except Trustees No. (1), (2), (3) (4) and (5) either or the other person as Trustees bearing in mind the aims and objects of the Trust.
- 22. The President shall have powers to decide on all matters pertaining to the objects of the Trust.
- 23. The President shall maintain or cause to decide on all matters pertaining to the objects of the Trust.
- 24. The PRESIDENT shall have the powers to appoint Teacher, Managers and others, Other members of the staff for different department and to fix their remuneration and frame service rules. And also have right to open Technical college/PUC college/Degree colleges, Societies and Associations in the name of the Trust.

# 25. POWERS AND DUTIES OF THE BOARD OF TRUSTEES:

The Trustees shall have full power and authority and administration in Trust. Its instruction, properties and funds to do acts, deeds and thing as are calculated to promote the object for which this trusts is established.
